What's New With VA OSDBU

Note from the Director

Coordinated for the eighth year by VA's Office of Small and Disadvantaged Business U liza on (OSDBU), the 2018 Na onal Veterans Small Business Eng agement (NVSBE) Targeted Indus try Eng agement event was held in New Orleans the last week in October. This was 3 days, 2 major events, and 1 loca on with Endless Opportuni es.

Focused on the construc on industry, the 2018 NVSBE was supported by 208 VA employees, and attracted 1,044 small businesses and 301 large businesses. The annual event provides visible demonstra on to all stakeholders of VA's commitment to enable Veteran-Owned Small Businesses access to economic opportuni es.


Co-located this year with Society of American Military Engineers (SAME) Small Business Conference, NVSBE is the centerpiece of the OSDBU Direct Access Program which enables Veteran-Owned Small Businesses and other small and large businesses to add value to VA procurement projects by providing them with direct access to VA, other federal agency and commercial buyers. VA's commitment to the construc on related industry included a FY 18 budget of \$5.9 Billion with an addi onal budget of approxima tely \$2 Billion for FY 2019. Both fiscal year construc on budgets will be extended to use in future years. This also includes more than 850 projects on Strategic Capital In vestment Planning (Minor Construc on and Non-Recurring Mairtenance) and 3,400 future projects (Minor Construc on and Non-Recurring Mairtenance). Secretary Robert Wilkie and Administrator Linda McMahon, head of the U.S. Small Business Administration (SBA) announced a new partnership dedicated to supporting Veteran Entrepreneurial Programs.

Secretary Wilkie and Administrator McMahon signed a Memo of Understanding between the SBA and VA to collaborate and scale a new pilot program that will offer intensive management and leadership training for Veteran entrepreneurs.

3 Days + 2 Events + 1 Place = Endless Opportunities

For three days at the end of fall, more than 1,300 businesses gathered in New Orleans to share information about their products and services directly with buyers and decision makers. This unique opportunity was the result of the Department of Veterans Affairs (VA) and the Society of American Military Engineers (SAME) co-locating VA's National Veterans Small Business Engagement (NVSBE) and SAME's Small Business Conference. Both events focused on construction services and started small businesses on the path to compete for more than \$5.9 billion in VA construction opportunities.

VA Now Uses SBA Eligibility Rules

VA began using the U.S. Small Business Administration's (SBA) regulations governing the ownership and control of Veteran-Owned Small Businesses (VOSB) and Service-Disabled Veteran-Owned Small Businesses (SDVOSB) on October 1. By consolidating the eligibility requirements for SDVOSBs and VOSBs, the SBA and VA hope to eliminate confusion.

This change does not move the verification process from VA to SBA. VA's Center for Verification and Evaluation (CVE), a subdivision of the Office of Small and Disadvantaged Business Utilization (OSDBU), will continue to verify that firms meet the ownership and control requirements under the regulations now provided by SBA. In addition, VA trains and certifies verification assistance counselors who are available to help with issues concerning a company's eligibility. <u>Find a verification assistance counselor in you area.</u>



SBA and VA Join Forces to Advance Veteran Entrepreneurship

On November 1, a Memorandum of Understanding (MOU) to offer intensive management and leadership training for Veteran entrepreneurs was signed between SBA and VA. SBA Administrator Linda McMahon and VA Secretary Robert Wilkie, announced the partnership between the agencies and the plans to scale this new program. "By signing this MOU between VA and the SBA, we are committing two federal agencies to advance, improve, and expand opportuni es for transi oning Servicemembers and Veterans to own their own businesses," says VA Secretary Wilkie. President Donald J. Trump showed his commitment to small businesses and Veterans by donating his second-quarter salary to the SBA.
